(ICAO Annex 6: Operation of Aircraft) The Operations Manual may contain some or all of the information contained in the Aircraft Flight Manual (AFM) , but it also contains much other information regarding the way in which flights are to be conducted.

### Cabin Safety - Federal Aviation Administration

The minimum number of cabin crew and the evacuation procedures form part of the Operations Manual. Reducing the minimum cabin crew is a deviation from the required minimum number and requires close monitoring. Changes to evacuation procedures with a reduced number of cabin crew are required to be acceptable to the Competent Authority.
